Enhances financial wellness by protecting employee savings and investment accounts from identity theft-related financial loss



Vision

Resolves misuse of benefits when an employee's identity and insurance are used to file fraudulent claims



Retirement

Secures retirement accounts from identity theft, ensuring long-term financial security



Legal

Provides legal support for identity theft cases and simplifies the process of reporting identity theft to credit agencies
